- **Isiqinisekiso seBeetle** - uhlolo malenziwe emva kwentengiso ngaphandle ke ukuba isivumelwano sentengiso sithi sizakuba semthethweni phambi komhla wentengiso.
- **Isiqinisekiso serhasi**: siyafuneka ukuba indlu inendawo esebenzisa irhasi. Kufuneka sikhutshwe phambi kokuba kuhlaliwe okanye kukhutshelwe egameni lo mthengi. Lo nto kufuneka yenzeke kwiminyaka emibini phambi kokuba kufike umhla wothengiswa. Lo nto kufuneka ichatshazelwe xa kusenziwa isivumelwano sentengiso.
- **Isiqinisekiso Sokulungiswa Kwemibhobho**: esi sisetyenziswa ngumaspala wesixeko saseKapa.
- **Isiqinisekiso/isatifikethi Sokufakwa Kocingo loMbane**: Qinisekisa ukuba umzi unalo ucingo lombane.
- **Izinto ezonakeleyo**: kufuneka umthengisi azilungise. Aphinde azichaze kwingxelo efunekayo malungana nobume bendlu yakhe.
- Kufuneka ufumane **ubume bemo yomhlaba**.
- Yeyiphi **imiqathango yetaytile ethintelekayo?** Fumana ikopi yetaytile kumthengisi okanye kwi ofisi yetaytile uyithumele kumthengi ayibone ukuze amkele yonke into ebhalwe kuyo.
- **Ingaba umthengisi akangomhlali malunga neenjongo zerhafu?** Ukuba indlu ixabisisa izigidi ezimbini (R2 Million), kufuneka kusetyenziswe umgcini mali/accountant
- **Ingaba ukhona umqeshi kwindlu?** Fumana isivumelwano sokuqesha – uyahlala okanye uyahamba umqeshi? Sichaphazele esivumelwano xa usenza isivumelwano sentengiso kwigatya lokuhlala.
- **Ingaba irhafu iyabhatalelwa?** Ihlawulelwa ngumthengisi ukuba inyusiwe phambi kokukhutshelwa kwindlu, ngaphandle ke ukuba isivumelwano sentengiso asiyichaphazeli.
- **Xa usayina ngemimiselo ye power of attorney?** Fumana ikopi. (kufuneka ibenomhla waphambi kwesivumelwano sentengiso.)
- **Ukuba yinkampani**: ingaba umsayini uyagunyaniswa ukuba athengise okanye athenge? Ingaba ikhona into echaza oko?
- Ingaba **inkampani** isekwi rejista yenkampani okanye isusive?
- **Ukuba umthengisi okanye umthengi uyi Trust**, kufuneka kubekho isibophelelo kwi Trust umhla phambi kokuthengisa okanye zonke iTrustees zisayine isivumelwano sentengiso. Ukuba ayenzekanga lo nto esivumelwano sentengiso asizukuba semthethweni. Kufuneka ufunane ikopi yeLetters of Authority.
